# **Colgate-Palmolive Recalls Fabuloso Multi-Purpose Cleaners Due to Risk of Exposure to Bacteria**

## **Recall Summary**

**Name of Product:** Fabuloso Multi-Purpose Cleaners

**Hazard:** The recalled products can contain *Pseudomonas* species bacteria, including *Pseudomonas aeruginosa* and *Pseudomonas fluorescens*, which are environmental organisms found widely in soil and water. People with weakened immune systems, external medical devices, or underlying lung conditions who are exposed to the bacteria face a risk of serious infection that may require medical treatment. The bacteria can enter the body if inhaled, through the eyes, or through a break in the skin. People with healthy immune systems are usually not affected by the bacteria

**Remedy:** Refund, Replace

Consumers should immediately stop using the recalled Fabuloso Multi-Purpose Cleaner products and contact Colgate-Palmolive Company for a full refund or a free replacement product. To receive a refund or replacement, consumers should take a picture of the product's UPC and lot code and dispose of the product in its container with household trash. ## **Description:**

This recall involves certain Fabuloso Multi-Purpose Cleaners, which is a multi-purpose cleaner that can be used to clean most residential hard surfaces. The first 8 digits of the lot code of the recalled products are 2348US78 through 2365US78 and 30001US78 through 3023US78.
