To Our Valued Customers:

This is to inform you of a voluntary product recall involving:
RED, YELLOW, AND WHITE ONIONS DISTRIBUTED FROM KEELER FAMILY FARMS
LABELED MVP, OUT OF THE CHIHUAHUA, MX. REGION FROM JULY 1, 2021 THRU
AUGUST 31, 2021.

Investigations into potential sources of Salmonella are ongoing but, to date, no onions marketed through Keeler Family Farms have tested positive for Salmonella. There is also no link to any domestic production from Keeler Family Farms.

The Keeler Family Farms voluntary recall is being conducted out of an abundance of caution, in cooperation with the U.S. Food and Drug Administration. Further information about the recall from the Center for Disease Control and FDA is available at their websites.

We appreciate your prompt attention to this matter and kindly request the following:

- Immediately examine your inventory and destroy product subject to this recall.
- In addition, if you may have further distributed this product, please identify your customers and notify them at once of this product recall. Your notification to your customers may be enhanced by including a copy of this recall notification letter. This recall should be carried out to the consumer level.
- Please complete and return the enclosed response form as soon as possible.

Contact Keeler Family Farms directly for instructions on what to do with the recalled product if any questions exist. This voluntary recall is being made with the knowledge of the Food

and Drug Administration. The FDA may contact you to confirm that you have received this notice and that you are carrying out the actions described within.
